- 2/ adoption of the Decision on granting a consent to the Supervisory Board's Decision on giving donations to legal persons in 2022.
- II Totally 7.764 stockholders, having 63.457.358 voting stocks and being registered in the Company's stockholders' list with the Securities Registry of the Federation of Bosnia and Herzegovina on 18 Nov., 2022 (30 days prior to the Assembly meeting date or prior to the last working day preceding that deadline if it is a non-working day) were entitled to participate and make decisions at the 72.
